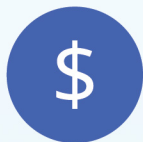

Privacy Notice

1. Data Privacy / Data Privasi

Viceroy Private Wealth Sdn Bhd., Registration No: 202101013151 (1413450P) collectively will be referred to as/secara kolektif akan disebut sebagai "Viceroy".

Viceroy will process your personal information strictly in accordance with the Personal Data Protection Act 2010, other relevant laws and Viceroy Group's strict internal policy. / Viceroy akan memproses maklumat peribadi anda secara tegasnya mengikut Akta Perlindungan Data Peribadi 2010, undang-undang lain yang berkaitan dan polisi dalaman Kumpulan Viceroy yang ketat.

2. Processing of Personal Data / Pemprosesan Data Peribadi

When you register your interest for this Program, the personal information that you submit ("Personal Data") will be collected, used, stored and processed by Viceroy and its employees, representatives, agents, service providers and affiliates to enable us to contact you and to facilitate your registration, performance and administration of this Program. / Apabila anda mendaftar untuk program ini, maklumat peribadi yang anda kemukakan ("Data Peribadi") akan dikutip, digunakan dan diproses oleh Viceroy dan pekerja-pekerjanya, wakil-wakil, agen-agen, pembekal perkhidmatan dan sekutusekutu untuk menghubungi anda dan memudahkan pendaftaran, pelaksanaan dan pentadbiran Program ini.

3. Impact resulting from failure to provide Personal Data / Akibat daripada kegagalan untuk memberikan Data Peribadi

You may choose whether or not to provide your Personal Data required for us to contact you and subsequently the additional Personal Data for verification and registration into this Program. 4. Purposes of Collecting and Using Your Personal Data / Tujuan Mengumpul dan Menggunakan Data Peribadi Anda

5. Disclosure of Your Personal Data / Pendedahan Data Peribadi Anda
